Governor Reynolds visits Calhoun County

On August 22, Governor Kim Reynolds visited Calhoun County on her 2024, 99-county tour. Many times, on these 99-county visits, the Governor visits businesses, special events or public events, so when the call for a small-group meeting was requested it presented the perfect opportunity to share all that has been developing in Calhoun County.

The three-year Calhoun County Economic Development Strategic Plan was the center of discussion for the two-hour meeting. Leaders from across Calhoun County shared the aspects of the plan and addressed some of the many challenges facing rural communities.

Housing and childcare are critical needs across lowa, and Calhoun County is at the center of this topic. "Manson is a community which needs both more housing and childcare options and provid-

ers," Macie Schoon, Manson Economic Development Coordinator elaborated. "We asked the Governor to help us find solutions and I am so excited for her attention to our requests and some of the action plans to help us find solutions to our issues." Barb Riley, Calhoun County Public Health Director, shared how the Calhoun County Health Improvement Plan mirrors the State of Iowa Health Improvement



Plan. Conversation regarding how the local public health presence is essential to keep our county surviving and thriving and the undetermined future HHS alignments are a concern of the Calhoun County Board of Health. The Governor indicated she agrees local services are valuable and necessary, especially in rural areas. Those in attendance left the meeting encouraged by the conversation, concern and attention of Governor Reynolds.

As one of few critical access hospitals who provide obstetrical care in Iowa, Ann Lengeling, Stewart Memorial Community Hospital Chief Nursing Officer, shared the investment this Calhoun county hospital is committing to their patients. Governor Reynolds applauded SMCH for their investment as well as recognizing the struggles of healthcare professional staffing at this time across Iowa.



Leadership Calhoun

Calhoun County Economic Development has received two grant awards totally \$3,500 in support of the CCEDC Strategic Plan – Collaborating for the Future, for the design and implementation of a new program "Leadership Calhoun." Grants from Iowa Area Development Group Foundation and Empower Rural Iowa signify their support of the strategic goal to develop this rural Iowa leadership program.

Identified as a local issues-awareness program, Leadership



Calhoun, is being modeled after the successful, 42-year, statewide "Leadership Iowa" program. This program is for aspiring and emerging Calhoun County Iowa leaders.

Design of the program will bring together 10-12 participants for eight, once-monthly sessions across Calhoun County to focus on the important topics of leadership, economic development, healthcare, education, government, agriculture, professional development and more.

Facilitators of Leadership Calhoun will be composed of a mix of local, regional and statewide leaders and professionals focused on strength based leadership.

Enrollment begins Summer 2025. Program start date is Fall 2025.

Foundation for Entrepreneurs

Calhoun County Economic Development is developing a tax-deductible foundation for the specific interest of encouraging entrepreneurs to establish, join or succeed a business in Calhoun County. Students are awarded scholarships upon high school graduation or when opportunities present for scholarship grant awards, but many times these students do not return to Calhoun County. The new Calhoun County Economic Development Foundation is designed to award scholarships to individuals interested in skilled trade training and apprenticeship programs who commit to return to Calhoun County following their training. Recruiting our own Calhoun County community members to work and own businesses in Calhoun County encourages the CCEDC "Grow Here" philosophy. CCEDC is looking for partners to contribute to the CCEDC Foundation as the fund is established and implemented.

As the CCEDC Foundation is currently in development, we encourage donors to contact the CCEDC Office to discuss the donation process. The gift of an endowment to this new foundation would ensure a legacy as we continue to support business development and business succession in Calhoun County.



CCEDC Revolving Loan Fund (RLF)

Calhoun county business owners and aspiring business owners may be eligible for a loan through the CCEDC RLF for new or expanding private businesses. Eligible uses of funds include land purchases, machinery, equipment, fixed assets, operating capital, and buildings.

Applicants of the RLF are required to meet their financial needs from their own resources and commercial financial institutions whenever possible. The RLF is intended to finance applicant gap needs. The minimum RLF is \$5,000, the maximum RLF loan will not exceed 50% of the approved project. RLF loans can be amortized over 7 years. Loan interest rates typically range from 1-5%. Security shall consist of the best lien available. The RLF application requires a written business plan. In certain businesses additional market studies, feasibility studies and other documents may be requested. The CCEDC RLF committee recommends working with the Iowa Small Business Development Center (SBDC) which can provide no-cost business advice and resources when growing or starting a business in Iowa. CCEDC RLF applications are confidential and submitted through the Calhoun County Economic Development Office.

Hub712 is a business resource center serving Audubon, Calhoun, Carroll, Crawford, Greene, Guthrie, Ida and Sac counties in western Iowa. Located at 603 N Adams Street in Carroll, Hub712 offers direct access to Small Business Development Center (SBDC) professionals, coworking plans, and a business lab. Specifically important to Calhoun County is the Ag Innovation Center within Hub712.

The Ag Innovation Center supports ag business sector entrepreneurs and innovators to bring inventions and ideas to fruition.

Thanks to committed partners, who fund this important work, services at Hub712 are no-cost. Partners include Iowa Economic Development Authority, Rural Ideas Network, U.S. Economic Development Administration, Advance Iowa, the Economic Recovery Corps, the International Economic Development Council, Carroll County Growth Partnership, Region XII Development Corporation and Iowa SBDC.

Calhoun County Community Foundation Grant 2025

Applications for the Calhoun County Community Foundation Grant are being accepted through January 7, 2025.

These grants are available to support 501(c)3 nonprofit organizations or government entities. Through this competitive application process, grants can be used for projects focused on community betterment, environment beautification, economic development, health & recreation, education, arts & culture, historic preservation and human services. Funds are intended for new projects, or for the enhancement or expansion of existing services, programs, or facilities.

Calhoun County Business Park

The Calhoun County Business Park project reflects the power of partnerships to bring new economic development to rural Iowa.

The Business Park project is spearheaded by a development team including the Calhoun County Economic Development Corporation (CCEDC), the Calhoun County board of supervisors, the Calhoun County Electric Cooperative Association (CCECA), and Corn Belt Power Cooperative (CBPC).

Since the completion of the four-lane U.S. Hwy 20



project in late 2018, traffic counts at the Calhoun County Business Park have risen nearly 55% to an average daily traffic count of approximately 9,000 vehicles.

Located in a federally-designated Opportunity Zone, which is designed to spur economic growth while providing tax benefits to investors, the area is also locally designated as an urban renewal area, offering potential financial incentives for development.

Today there are 13.2 sellable, shovel ready (water, sewer, electric services on-site) acres made up of four lots ranging from 1.5 acres to 4.7 acres. The ability to accommodate much larger land requests is also available.

Highway 20 Corridor Marketing Grant

Iowa Area Development Group has received an award from the USDA RD Rural Business Development Grant program to conduct site assessment and marketing study for business parks and sites along U.S. Highway 20 which includes the Calhoun County Business Park.

The focus of the project will be to develop a Marketing Strategy for the US 20 sites that will consist of a Research, Planning, and Marketing strategy. The overall goal of this Strategy is to develop a consistent plan along the US Hwy 20 Corridor to market existing sites and promote opportunities for new or emerging business within the locations identified and researched. This effort will allow development professionals' critical information and tools to promote the active sites. Initial meetings are underway with an expected completion date of the assessment mid-year 2025.
